

## **Bridges to Understanding Workshop Registration form**

### **Workshop Attendee Release**

I have voluntarily chosen to participate in a Bridges to Understanding (“Bridges”) workshop. In so doing, I acknowledge that I may be subjecting myself to dangers and hazards, which could result in illness, injury or death. I also acknowledge that there are inherent risks and dangers, which may arise at any time during the workshop, and that medical services or facilities might not be available. Bridges reserves the right to cancel or change the itinerary or instructors without prior notice, and reserves the right to cancel the registration of any participant it determines fails to meet its requirements.

In consideration of my being permitted to participate in the workshop:

**1. Personal Injury/Property Damage.** I agree to **assume all risks** of illness, injury or death and agree **not to sue** and to **release from liability and indemnify Bridges to Understanding**, its owners, officers, agents, and employees and other persons or entities involved with this workshop, from all actions, claims or demands for injury, loss or damage regardless of the cause resulting from my participation in the workshop. I understand that Bridges may contract with independent contractors to provide services for this workshop, and acknowledge that Bridges has no control over and assumes no responsibility for the actions of any independent contractors.

**2. Intellectual Property.** I grant a non-exclusive license to Bridges and any of its assignees the unfettered right, throughout the universe in perpetuity, to commercially exploit, transmit, publish, record, edit, promote and otherwise distribute in any media, now or hereafter invented all of my original works of authorship created during the workshop. Further, Bridges may use my name, voice, signature, photograph or likeness for any purpose (commercial, promotional or otherwise) related to the Bridges program. Bridges shall be entitled to keep all revenues generated therefrom provided such revenues are applied only for the support of Bridges. Subject only to the foregoing license(s), I shall retain the copyright in all of my original works of authorship.

I have carefully read this agreement. I understand that it is a **release of liability** and a **contract** between me and **Bridges to Understanding**, and I sign this agreement of my own free will. The terms of this agreement shall be binding on my heirs, executors, administrators and all members of my family, including any minors accompanying me.

## **Withdrawal and Refund Policy**

To provide the best experience for all participants we keep the size of our workshops small, therefore, once you have registered, we are counting on you to attend. If you must withdraw from a course, we provide the following refund policy:

### **International workshops**

- Withdraw more than 60 days before the start of workshop and we will refund all monies paid, less a \$50 administrative fee.
- Withdraw less than 60 days before the workshop there is a 50% refund of monies paid, less a \$50 administrative fee, remaining monies paid can be applied for a future BRIDGES Workshop.

### **Seattle workshops**

- Withdraw more than 30 days before the start of workshop and we will refund all monies paid, less a \$25 administrative fee.
- Withdraw less than 30 days before the workshop there is no refund, but monies paid can be applied for a future BRIDGES Workshop.

### **Course Cancellation**

Occasionally, we cancel a class because of low enrollment. In this case, we will refund all monies paid, in full. We cannot be responsible for non-refundable airline tickets unused because of a course cancellation. We suggest participants purchase travel insurance to protect them in this event. Our limit of liability is only to return monies paid to BRIDGES.

### **Instructor Replacement**

Occasionally a listed instructor is unable to participate because of a change in his or her professional schedule. If we are forced to replace an instructor, we will do so with someone of equal or similar credentials. When time permits, we will inform all those registered.
